- 1. APOLOGIES FOR ABSENCE AND DECLARATIONS UNDER THE CODE OF CONDUCT AND REQUESTS FOR DISPENSATIONS Apologies were received from Cllr Bird, Cllr Wheatley, Cllr Badger

3. PLANNING/TREE WORK APPLICATIONS

3.1 Planning Ref 20/02674/HFUL

2 North Brook End –Erection of cartlodge with room over and additional outbuilding Cllr Traverse-Healy advised that the proposed building would be outside the village framework and suggested a condition for the withdrawal of permitted development rights, should the application be successful, as the house was in the countryside.

He also suggested that it be requested that the room over the garage remain as part of the main house. Councillors agreed to support the application with these comments. *Recommendation -Support*

4. CAMBRIDGESHIRE ACRE –HOUSING NEEDS SURVEY

Kieran Carr, Economic Programmes Manager Cambridgeshire ACRE, referred to the recent outline planning consent for affordable housing which was subject to a Housing Needs Survey to determine the house types. The Parish Council was asked for their support in carrying out the survey and assistance with encouraging the completion of the survey through a covering letter. A draft had been circulated to Councillors.

The Clerk was asked to circulate the information again and also ask Mr Carr for a copy of the survey questions. This would be an agenda item for discussion at the Parish Council meeting on the 14th September.

5. OTHER PLANNING ISSUES

5.1 Station Road Planning Application

It was noted that there had been a lot of inaccuracies commented on social media relating to the successful planning application. Cllr Upchurch added that there were also references to the Parish Council giving in and granting permission against the views of the rest of the village. The comments did not acknowledge that South Cambridgeshire District Council was the planning authority and the Parish Council was only a consultee. Councillors agreed not to respond at this time.
